MEMBERSHIP

Dear Friends,

How is Congregational Membership defined in the Episcopal Church?

Our primary source for the following definitions comes from the Constitution and Canons of The General Convention of the Protestant Episcopal Church in the United States of America (yes, I had to look up the full title!), with additional references to the Diocese of Southern Ohio Canons and to St. Mary's Bylaws. Here are the definitions (with added comment when appropriate):

A Member is defined as: Any person who has received the Sacrament of Holy Baptism with water in the Name of the Father, and of the Son, and of the Holy Spirit, whether in this Church, or in another Christian Church, and whose Baptism has been duly recorded in the Congregational Registry of this Church, is a member of the Episcopal Church and of the Congregation. [Canon I.17.1 (a)]. The Episcopal Church does not require rebaptism (quite the contrary) or an affirmation of Faith, to become a member. Simply let the office know of your desire to be a member and when and where you were baptized. If you have not been baptized, we can baptize you (after instruction)!

Members who are sixteen years old or older are Adult Members [Canon I.17.1 (b)]

Members who receive Holy Communion at least three times during the preceding year are Communicants [Canon I.17.2 (a)]. Those Communicants who for the previous year have been faithful in corporate worship (unless for good reason prevented), and have been faithful in working, praying, and giving for the spread of the Kingdom of God, are Communicants in Good Standing [Canon I.17.3].

Adult Communicants in Good Standing are eligible to vote in Parish Meetings for Vestry members and for other Parish business. [Diocese of Southern Ohio Canon XVI.2 and Parish Bylaw II.1 (c)]

Now, what about Confirmation?

All Adult Members are expected (after appropriate instruction) to make a mature public affirmation of their faith and commitment to the responsibilities of their Baptism and to be confirmed or received by the laying on of hands by a Bishop of this Church. [Canon I.17.1.(c-d)]. Confirmed Adult Communicants in Good Standing are eligible to be elected as Delegates to Diocesan Convention and to be licensed by the Bishop for various ministries: Pastoral Leader, Worship Leader, Preacher, Eucharistic Minister (Chalice Bearer), Eucharistic Visitor, Catechist, and Evangelist. [Canon III.4.2-9].

So, lots of categories, lots of definitions!

To me the most important is Communicant in Good Standing, that is, a person who is faithful in worship, working, praying, and giving for the spread of the Kingdom of God.

So where are you on this list?

Where do you want to be? I am available to answer your questions and concerns as we work at St. Mary's to spread the Kingdom of God.

Sewanee Church Music Conference

The second full week of July was the SCMC and I attended....virtually, as all did. It worked quite well, although we only met for a couple hours in the morning and a couple in the evening.

Current Dean of Theology at Sewanee (but stepping down in August) Dr. J. Neil Alexander, spoke on Wednesday morning. He was our clergy several years ago and he a very kind and thoughtful man as well as being a former church organist! He talked about our return to somewhat normal life in the church and that he really had looked forward to singing. "CHRISTIANS SING!," he said.

Some other comments included that our hymn tunes carve into our souls, into our minds and into our hearts. As example, and you may well relate to this, he mentioned that when he is trying to recall the words to a hymn, he often must sing the words he knows and when he gets to the words he had trouble remembering, they are there, as the tune had carved its way into him. He also pointed out that in the 1982 Hymnal, you'll find very few hymns with "I" used. The majority of hymns incorporate "WE" which points us to the corporate worship we should experience.

Neil believes that Parish health and growth is vitally tied to congregational singing. There would be a soulful disconnect if we didn't sing together.


