THE PLACE OF MUSIC IN WORSHIP

Dear Friends,

I promised you last month that this month's article would be about the place of music in Episcopal worship. I fear I bit off FAR MORE than I can chew!

After working on my article for several weeks, I finally decided that this subject was worth far more attention than I could give it in a monthly newsletter. With the invaluable assistance of John Glaze, we will be learning about the history and place of music in Anglican/Episcopal worship during the season of Lent (March 6 – April 3, 2022). By this time the pandemic will have (God willing) moved into its endemic stage and we can begin to have Coffee Hour again and present this series in that format. If we can start earlier, we will! And, if we need to continue past Easter, we will!!

The books we will be using are:

The Bible
The Book of Common Prayer (1979)
The Hymnal (1982)
and authorized supplements
Welcome to Church Music & The Hymnal
1982 (Matthew Hoch). We will have copies
available.

Here's a few tidbits for you in the meantime: Psalm 96:1-2

"Sing to the LORD a new song; Sing to the LORD, all the whole earth. Sing to the LORD and bless his Name; Proclaim the good news of his salvation from day to day."

[Attributed to Saint Augustine of Hippo]: "He who sings [in worship] prays twice".

Rubrics from the Book of Common Prayer (page 14):

"Hymns referred to in the rubrics of this Book are to be understood as those authorized by this Church. The words of anthems are to be from Holy Scripture, or from this Book, or from texts congruent with them.

On occasion, and as appropriate, instrumental music may be substituted for a hymn or anthem.

Where rubrics indicate that a part of a service is to be "said," it must be understood to include "or sung," and vice versa.

When it is desired to use music composed for them, previously authorized liturgical texts may be used in place of the corresponding texts in this Book."

Vestry Report

Last month you may recall being asked:

"Why is St. Mary's Episcopal Church important to you?"

As noted in the article, you were asked to stay tuned for further details. I am pleased to report that those details are being put in place!

All Vestry and active parishioners are invited to attend a meeting after church on November 14; the meeting is planned to last about 2 hours. Father David has drafted some language that we will discuss and review at this November 14 meeting. Once any revisions are complete and agreed upon, those present will be asked to sign the document indicating their endorsement of these statements. Additionally, those present will be invited to supply items to go on a list of "Whats" that will be discussed at our annual meeting. In the time after the November meeting, the Vestry will interview non-parish stakeholders to get their perspectives of what the city and county needs. These needs will be listed and compared to the HOW and WHY of St. Mary's. The WHATS will be discussed at the January Vestry meeting, with the outcomes presented at our annual parish meeting. The WHATS list approved by the Vestry will be reflected in the budget.

This process stems from a New York Times bestseller by Simon Sinek titled "Start with Why." Sinek is "an optimist who believes in a brighter future for humanity" (from the intro to the book). Sinek believes all highly successful organizations have developed the capacity to explain why they do what they do, in addition to explaining what they do. The discussions on the "why" of our church will provide clearer understanding of the reasons and beliefs behind our support of St. Mary's, and help us revise and renew our understanding of the mission of our church.

Please mark your calendars and plan on joining us for Worship on November 14 and staying for the meeting afterward. This discussion is open to all parishioners and we hope you can attend and help St. Mary's continue as we work to more clearly understand and act on what God is calling St. Mary's to do.

Our proclamation is rooted in the Great Commission (Matthew 28:18-20), the Summary of the Law (Matthew 22:36-40), and the worship of God (John 4:23-24).

THE HOW OF SAINT MARY'S

[Adapted from the Mission Statement "The mission of St. Mary's Episcopal Church is to share the joy of a loving God through worship in the Anglican tradition, fellowship, and service."]

We proclaim the Kingdom of God through the Anglican/Episcopal Tradition, as handed on to us by the Book of Common Prayer, the Lambeth Quadrilateral of 1888*, and the authorized teachings of the Episcopal Church.

*Resolution 11 of the Lambeth Conference of 1888


The Holy Scriptures of the Old and New Testaments, as "containing all things necessary to salvation," and as being the rule and ultimate standard of faith.

The two Sacraments ordained by Christ Himself – Baptism and the Supper of the Lord – ministered with unfailing use of Christ's words of Institution, and of the elements ordained by Him.

The Historic Episcopate, locally adapted in the methods of its administration to the varying needs of the nations and peoples called of God into the Unity of His Church.


